ACCEPTED CONFERENCE PARTICIPANT REQUIREMENTS

All presenters, including pre-conference presenters, moderators, and poster session participants, must have current (2019) [individual membership](#) **AND** be [registered](#) for the conference no later than **July 25, 2019**. Membership and conference registration are two separate processes and require separate fees. Each presenting member of a panel, workshop, or presentation (including moderators) must meet these requirements. **When renewing online, it is important to log in to renew your membership using the same credentials you used to submit your proposal (including Guest Login credentials).** Please do not create a new account or your membership and registration will not be linked to your proposal.
